ORDINANCE NO. 314 Series of 2019

"AN ORDINANCE ENACTING THE GAD CODE OF THE MUNICIPALITY OF ROSARIO, PROVINCE OF CAVITE"

CHAPTER I GENERAL PROVISION ARTICLE I

TITLE, STATEMENTOF POLICY AND DEFINITION OF TERMS

Section 1. Short Title. This ordinance shall be known as "The Revised Gender and Development Code of Municipality of Rosario, Cavite."

Section 2. Legal Mandate. The revision and adoption of this GAD Code is in line with the thrust of the Municipality of Rosario to promote women's economic empowerment, gender equality, gender-responsive development and governance and fulfill women's human rights in accordance to existing international convention, laws and local legislation.

SECTION 3. Declaration of Principles, Policies And Strategies— Consistent with national and local legislation, this Code is a concrete proof of the Municipality's commitment to adhere to the democratic principle that men and women are equal. It shall be the policy of the Municipality to uphold the rights of the belief in women's worth and dignity as human beings. Women shall be recognized as full and equal partners of the men in development and nation building and men shall share equally with all forms of productive and reproductive activities.

The Municipality of Rosario shall consciously contribute to the establishment of a national and international economic order based on sustained, equitable growth and balanced ecology. Any development effort it undertakes should enhance women's full potentials, uplift their status a and lead to improvement of their quality of lives, their families and that of their communities.
